Preamble:

Scientific publishing of academic research is an important tool for renewing and developing knowledge and improving the of higher education and scientific research in various scientific fields, including legal Published academic research is one of the most important objective criteria adopted various international university classifications such as: Shanghai, British "QS", Spanish "webometrics" and others, which prompted many countries, including Algeria, to put in place important motivations to encourage researchers to excel and innovate in scientific publishing, but practical application clearly reveals the need to evaluate and review the mechanisms for providing these motivations in light of successful international experiences.

Despite the important role expected from digitizing the scientific publishing process through the National Platform for Scientific Journals ASJP to facilitate and accelerate publishing procedures, some researchers face many obstacles in this field. Not to mention the difficulties they face in publishing their legal research in Arabic in high-impact international scientific journals. Although the scientific publishing process in Algeria has witnessed great activity in recent years, as many scientific journals have been established in various research fields, including legal journals, but many of them still suffer from the problem of not being classified in high-impact international journals.

The national forum aims to shed light on the reality and prospects of the scientific publishing process in Algeria by opening the way for specialists and researchers to explore and discuss the following problem:

To what extent does scientific publishing contribute to ensuring the quality of scientific research and raising the level of cognitive training in Algerian university institutions, through the rapid digital transformation?

Forum Objectives

The forum aims to achieve a set of objectives, the most important of which are:

1/.Identifying researchers to the mechanisms of safe scientific publishing of their research in various national and international classified scientific journals.

- 2/. Presenting an evaluative reading of the reality of the scientific publishing process through the national platform for scientific journals, and proposing appropriate solutions to redress the gaps and shortcomings that infect the process,
- 3/.Identifying the motivations provided to encourage researchers to publish their scientific research in high-impact scientific journals, reviewing the most important challenges that hinder researchers from benefiting from them, and proposing appropriate solutions to review their submission mechanisms.
- 4/.Identifying successful international experiences in the field of organizing and managing scientific publishing in scientific journals.

5/.Identifying the difficulties and obstacles facing researchers in the field of publishing in classified scientific journals inside and outside Algeria. And discussing appropriate proposals to promote international scientific publishing in the field of legal sciences.

Main Axes:

The first axis: Basics of publishing in classified scientific journals.

The second axis: Contribution of the Algerian platform for scientific journals ASJP to developing scientific publishing in Algeria and improving the quality of scientific research.

The third axis: Official efforts in the field of financing and supporting scientific publishing of academic research and the inevitability of promotion.

The fourth axis: Difficulties and obstacles to publishing in classified scientific journals and mechanisms for promoting it in the challenge of ensuring research quality.
